

January 9, 2012
City Council Meeting Minutes

Meeting called to order at 7:00 p.m. by Mayor Henry. Council members Kearney, Knepper, Moriarity and Soppe answered roll call. Motion Knepper, 2nd Soppe to approve the agenda – all ayes.

Motion Kearney to approve the temporary appointment of Greg Staner to fill the vacant Council seat until the February 7, 2012 Special Election failed for lack of a second. Motion Soppe, 2nd Knepper to approve the temporary appointment of Bill Hosch to fill the vacant Council seat. Kearney, Knepper, Soppe – ayes, Moriarity abstained per Chapter 71 of the Iowa Code noting a relation to the appointee.

Mayor Henry administered the Oath of Office to Bill Hosch and Hosch took a seat at the Council table.

There were no speakers from the floor.

Motion Knepper, 2nd Moriarity to approve the consent agenda items – all ayes.

Motion Kearney, 2nd Soppe to approve the 2nd reading of Ordinance 28-12 amending the Cascade Zoning Ordinance and the conditional zoning requirement on Marty Gaiant's and Leo & Tammy Moriarity's A1 pasture land on the east side of Buchanan St SW. Kearney, Knepper, Moriarity, Soppe, Hosch – all ayes.

Motion Soppe, 2nd Knepper to approve setting a proposed compensation and benefit package to discuss with candidates as discussed in the Council work session – all ayes.

Motion Moriarity, 2nd Soppe to approve the request from Cascade EMS Coordinators, Joe & Peg Reiff to allow for Pamela Barton, 230 Harrison St NW to volunteer clerical services to the Cascade EMS – all ayes.

Motion Soppe, 2nd Moriarity to accept Pat Kearney's resignation from the Cascade Board of Adjustment – all ayes.

Motion Moriarity, 2nd Kearney to accept Joyce Donovan's resignation from the Cascade Park Board – all ayes.

Motion Soppe, 2nd Moriarity to appoint Brad Boffeli to the remainder of Joyce Donovan's term on the Cascade Park Board which ends December 31, 2012, as recommended by the Park Board – all ayes.

Motion Moriarity, 2nd Soppe to appoint Shelley Annis and Phil Gehl as Joint Interim City Administrators – all ayes.

Motion Moriarity, 2nd Knepper to appoint Marty Hoffmann as Interim Zoning Administrator – all ayes.

Chief Heim reviewed Police Reports and answered questions.

Interim Administrator Annis reported that the Park Board will be seeking estimates for repairing the Riverview Park wall, the City workers have been making repairs to equipment and that Annis will be working on the proposed FY13 Budget this week.

Mayor Henry reminded Council of the upcoming phone interviews on Wednesday & Thursday and that those will most likely be in closed session and being held in the Administrator's office; a Budget Work Session is scheduled for Tuesday, January 17th from 5:00-7:00 and reminded everyone that on Tuesday, February 7th the Special City Council Election will be held here at City Hall.

Motion Moriarity, 2nd Hosch to adjourn the meeting at 7:45 p.m. – all ayes.
